- Richloam Tobacco Company sources all U.S. tobacco types through Direct Farmer Contracts as well as Auction Purchases.
- Resurgence of Flue-Cured Virginia Tobaccos, U.S. Burley Tobaccos, and Maryland Type Air-Cured Tobaccos Auctions
- From 2013 2016, Richloam sold or contracted approximately 15 million kilos of tobacco.











# **Richloam Volumes by Year**
